About the Awards

There are two important sides to Law Enforcement: *the sworn officers* that put their lives on the line every day to protect Americans from the threat of extremism, terrorism and hate, often our community's first line of defense; and *the prosecutors*, who work tirelessly to ensure the offenders receive the punishment accorded by law. The **Anti-Defamation League's Excellence in Law Enforcement Award** recognizes both the INVESTIGATIVE and the PROSECUTORIAL roles of law enforcement, identifying those members who are so deeply committed to their work that they have gone above and beyond expected efforts to protect the community.

The Anti-Defamation League's Excellence in Law Enforcement Award is unique in the country. No other private organization publically recognizes leadership in law enforcement in the areas of hate crimes, domestic terrorism, civil rights and public-private partnerships quite like the Anti-Defamation League (ADL). Additionally, no other human and civil rights organization values the long-standing partnership it shares with the men and women of law enforcement as much as the ADL; and this award strives to demonstrate the depth of that appreciation.

Award Presentation

For the first time, the Anti-Defamation League's Excellence in Law Enforcement Awards will be presented at a gala dinner in May 2015 in West Palm Beach. The dinner will honor men and women in uniform, along with the recipient of the 2015 West Palm Beach Jurisprudence Award. Invited guests will include supervisors, commanding officers and other special guests of the honorees, as well as past awardees. The honorees will receive a plaque in recognition of their excellence and an ADL press release will be issued prior to the awards ceremony. This will provide an opportunity to showcase the individual's or department's accomplishments to local media outlets, and to share successful programs and activities with other agencies. Criteria

This award will focus on activities within the law enforcement community in Florida – police agencies, legal and executive branches of the government, training departments, etc. – on the local, regional and federal scale that demonstrate relentless dedication to containing and minimizing the prevalence and severity of hate motivated behavior.

Some examples of quality applicant criteria may include, but are not limited to:

- Demonstrating an outstanding commitment to combating extremism, bigotry and hatred by performing acts outside the normal scope of duties; Strengthening police/community relations; Promoting civil rights in the community; Conducting officer training to improve skills in fighting hate motivated behavior; Providing public information and/or education to promote diversity and human rights; Using innovative approaches to the enforcement or prosecution of existing hate crime laws; Effectively using public-private partnerships to produce a civil rights conviction.

Selection Process

A distinguished group of experts will choose this year's honorees, including members of the law enforcement community from throughout the state of Florida, past award winners, and select members of the Florida ADL Law Enforcement Committee (Selection Committee names are listed on page one of this application form).
